APPLICATION PROCEDURE

E-mail your application to The Director, at anupam.paper@gmail.com along with 6-10 images of recent artworks, curriculum vitae, image of age proof certificate (required for students and junior professionals) and synopsis of the proposed project. The period of residency should also be mentioned. Applications will be accepted throughout the year. Please make sure that the application is in English.

SELECTION

At the discretion of the Director of the Academy, based on the credentials of the applicants, their recent works as well as recommendation from other artists/ designers/well wishers.

MATERIALS PROVIDED

- **PAPERMAKING**
Cotton rag and plant fibre pulp, Dyes, Cooking and bleaching agents.
- **BOOKBINDING**
Binding tools, Hard Board, Mill-made paper, Backing paper, Binding thread and Adhesive.
- **PRINTMAKING**
Proof ink, Acid, Front and back stop out, and cleaning solvents.
